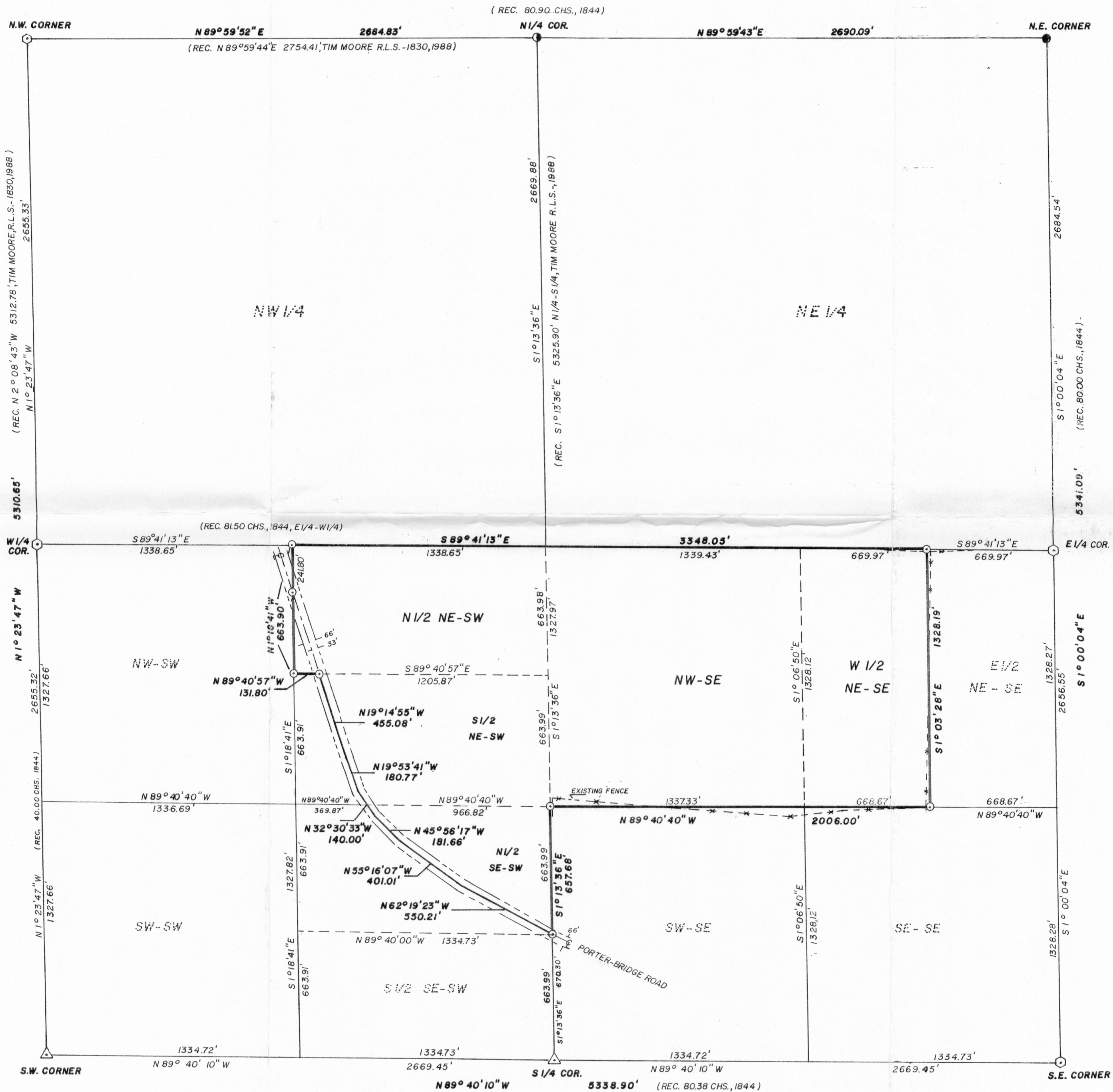
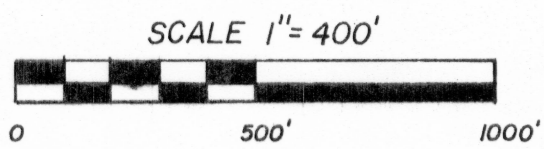


PLAT OF SURVEY

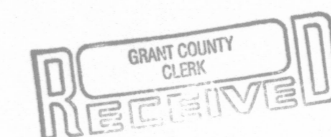
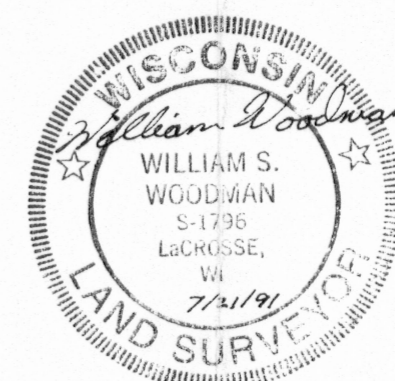
