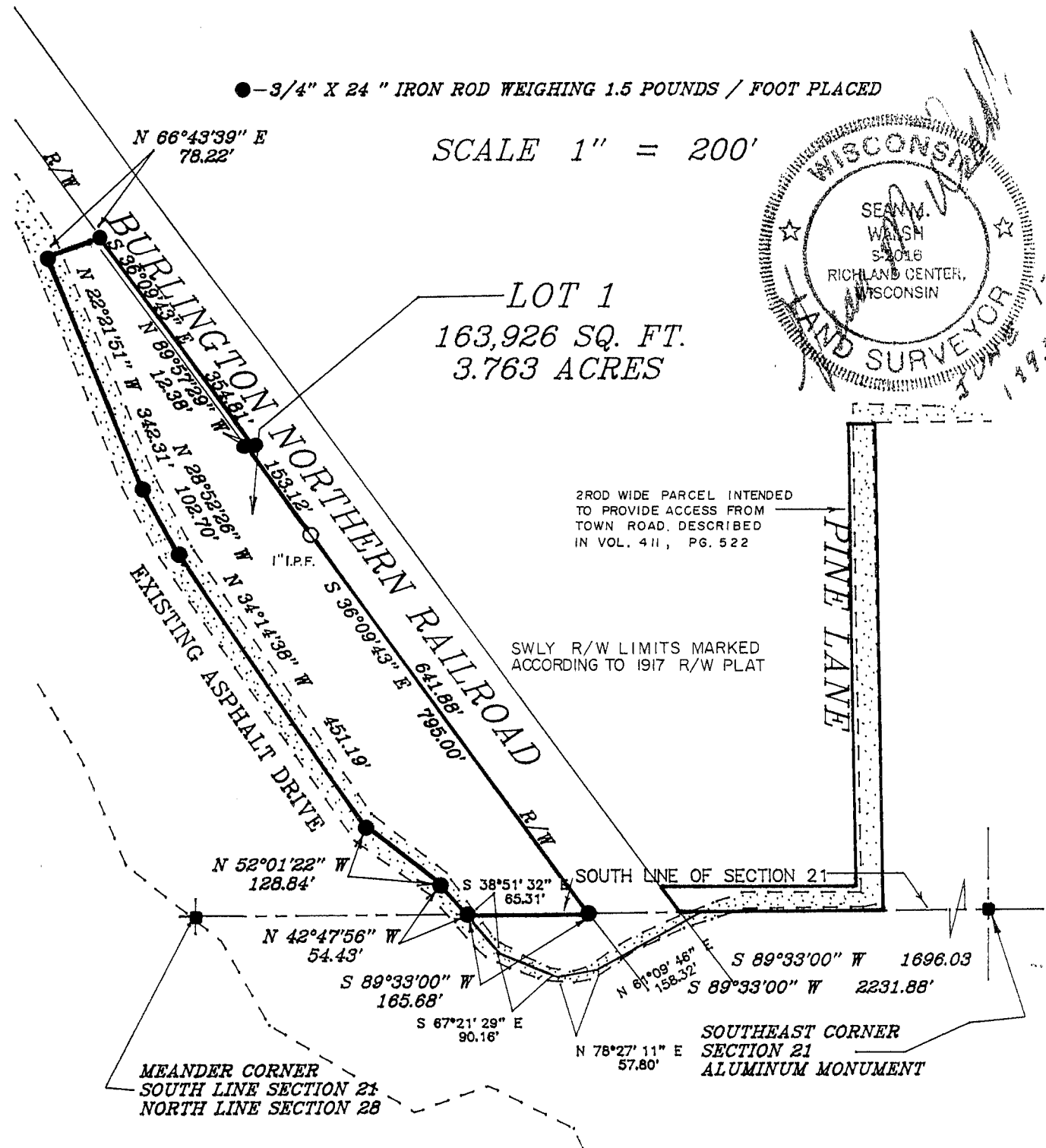

SURVEYOR'S CERTIFICATE



Walsh, Registered land Surveyor, do hereby certify that I have surveyed, divided and mapped all that part of the Southwest One-quarter of the Southeast One-quarter of Section 21, Township 5 North, Range 6 West, Town of Bloomington, Grant County, Wisconsin, bounded and described as follows:

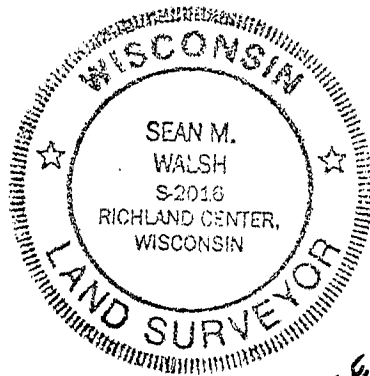
Commencing at the Southeast corner of Section 21; thence South 89° 33' 00" West, along the South line of Section 21, 1696.03 feet to the place of beginning of the parcel hereinafter described; thence continuing South 89° 33' 00" West, along said south line, 165.68 feet; thence North 42° 47' 56" West, 54.43 feet; thence North 52° 01' 22" West, 128.84 feet; thence North 34° 14' 38" West, 451.19 feet; thence North 28° 52' 26" West, 102.70 feet; thence North 22° 21' 51" West, 342.31 feet; thence North 66° 43' 39" East, 78.22 feet to a point on the Southwesterly Right-of-way limits of the Burlington Northern Railroad; thence South 36° 09' 43" East, along said Right-of-way limits, 354.81 feet; thence North 89° 57' 29" West, along said right-of-way limits, 12.38 feet; thence South 36° 09' 43" East, along said right-of-way limits, 795.00 feet to the place of beginning, containing 163,926 square feet or 3.763 acres of land.
