 THENCE SE'LY 206.27' ALONG SAID CENTER LINE ON THE ARC OF A CURVE CONCAVE NE'LY, HAVING A RADIUS OF 390.16' AND A LONG CHORD WHICH BEARS S 29°24'42"E 203.88';  
 THENCE SE'LY 86.56' ALONG SAID CENTER LINE ON THE ARC OF A CURVE CONCAVE NE'LY, HAVING A RADIUS OF 2164.02' AND LONG CHORD WHICH BEARS S 45°42'11" E 86.55';
