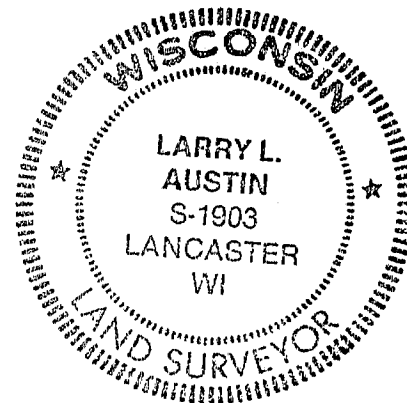

THENCE WEST 247.18' ALONG THE NORTH LINE OF SAID SECTION 2, TO A 1" IRON PIPE;
THENCE S 17°34'40" E 213.28' TO A 1" IRON PIPE;
THENCE EAST 181.31' TO A 1" IRON PIPE;
THENCE N 00°24'43" E 203.33' TO THE POINT OF BEGINNING CONTAINING 1.000 ACRE, MORE OR LESS, AND BEING SUBJECT TO ANY AND ALL EASEMENTS OF RECORD INCLUDING BUT NOT LIMITED TO A 25' WIDE INGRESS-EGRESS EASEMENT THE CENTERLINE OF WHICH IS DESCRIBED BELOW:

THENCE N 76°39'47" W 109.46' ALONG THE CENTERLINE OF A PURPORTED TOWNSHIP ROAD;
THENCE S 87°57'45" W 56.18' ALONG THE CENTERLINE OF A PURPORTED TOWNSHIP ROAD;
THENCE N 80°09'39" W 23.53' ALONG THE CENTERLINE OF A PURPORTED TOWNSHIP ROAD;
THENCE N 68°20'10" W 49.13' ALONG THE CENTERLINE OF A PURPORTED TOWNSHIP ROAD;
THENCE N 39°19'55" W 13.35' ALONG THE CENTERLINE OF A PURPORTED TOWNSHIP ROAD TO THE POINT OF BEGINNING;
THENCE N 45°35'07" E 72.57';
THENCE N 56°22'06" E 79.79' TO THE TERMINUS POINT.

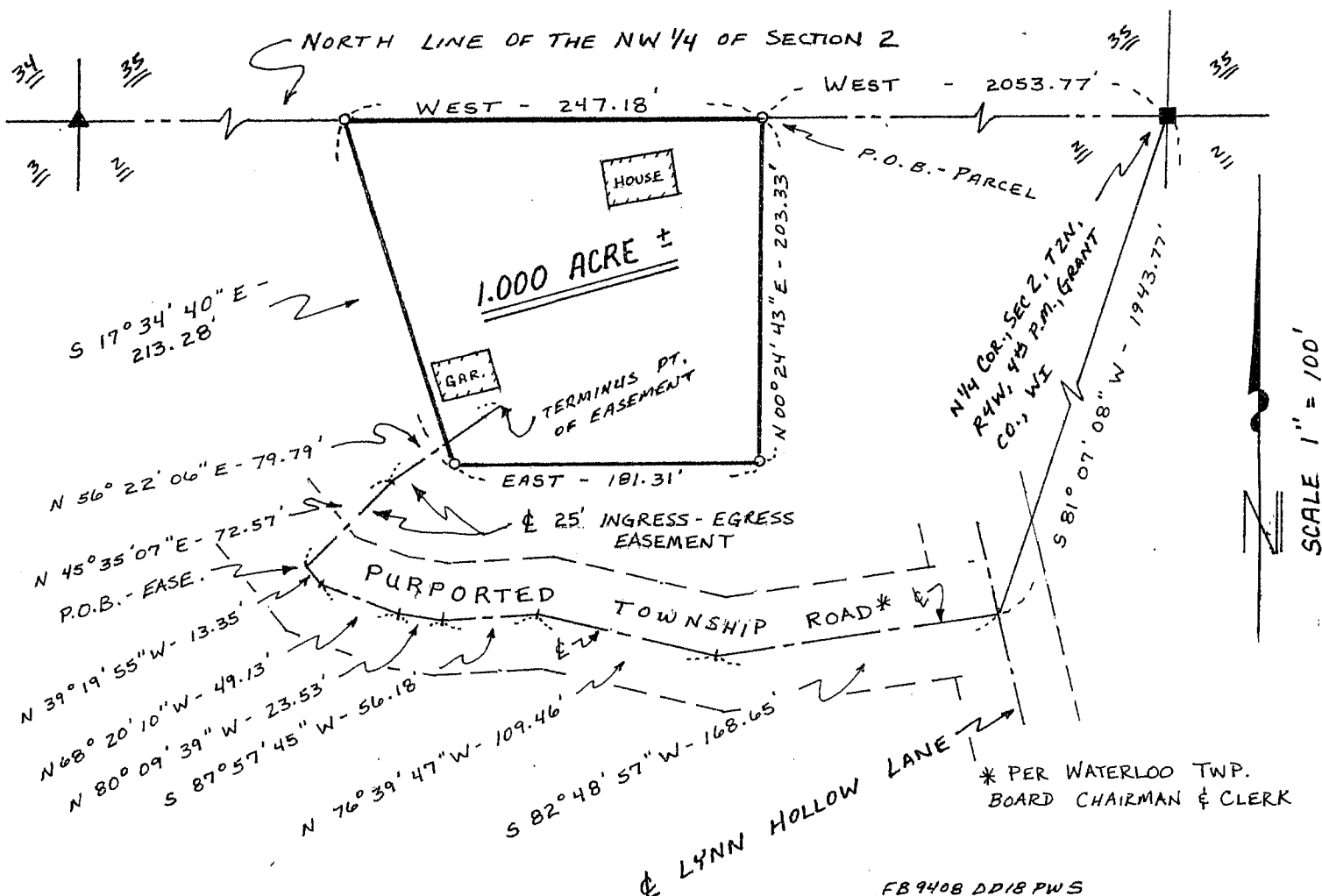
