
Commencing at the Southeast Corner of the Southeast 1/4 of said Section 36; thence N88°30'39"W, 1247.77' along the South line of the SE 1/4 of said Section 36; thence N01°05'42"W, 490.36' along the Easterly right-of-way of S.T.H. "80"; thence continuing along said right-of-way 11.16' along the arc of a curve concave to the East, having a Radius of 11,410.00', a Central Angle of 00°03'22", a Chord Bearing of N00°59'14"W and a Chord Length of 11.16' to the Point of Beginning; thence continuing along said right-of-way 400.02' along the arc of a curve concave to the East, having a Radius of 11,410.00', a Central Angle of 02°00'31", a Chord Bearing of N00°02'42"E and a Chord Length of 400.00'; thence S88°59'37"E, 545.00' along the South line of a parcel of land recorded in Volume 649, Pages 764 and 765 of the Grant County Registry; thence S00°03'31"E, 404.59'; thence S88°30'39"W, 545.00' to the Point of Beginning.

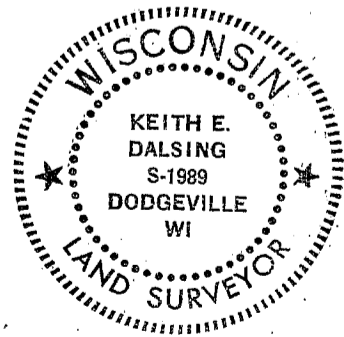
Said parcel contains 5.032 Acres and is subject to any and all easements and right-of-ways of record.
