PARCEL ONE (VOLUME 564 PAGE 440)

"Begin at NE corner of Block 4 of Burt's Addition to the Village (now City) of Lancaster, Grant County, Wisconsin, thence W to the NW corner of the E 3/4 of said Block 4, thence N 148 feet, thence E 200 feet to the E side of Block 5 of said Burt's Addition, thence E 102 1/2 feet, thence S 148 feet, thence W to the place of beginning. Also, a parcel sometimes known as Lot 5, Block 5 of Burt's Addition to the Village (now City) of Lancaster, Wisconsin, described as follows: Commencing at the Northwest corner of the property above described; running thence N 212 feet; thence E 114 feet; thence S 212 feet; thence W 114 feet to the place of beginning, being a part of Block 5, Burt's Addition to the City of Lancaster."


PARCEL TWO

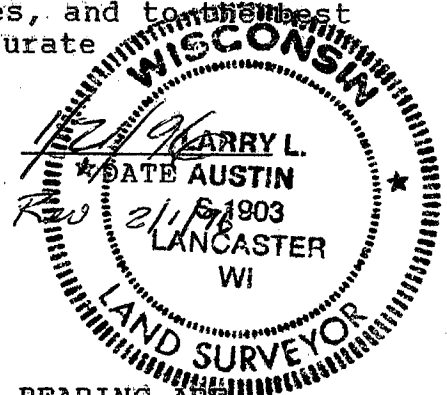

PARCEL THREE

A parcel being located in Block 4 of Burt's Addition to the Village (now City) of Lancaster, Grant County, Wisconsin, said parcel being more particularly described as follows; Commencing at the Southeast corner of said Block 4; thence N 89 45'47" W 175.00' along the South line of said Block 4 to a SE corner of that property described in Volume 691 at Page 933, Grant County Registry, Lancaster, Wisconsin; thence N 00°04'17" W 110.00' along an East line of said property to a point, said point being the NW corner of that property described in Volume 580 at Page 198, of said Registry, said point also being the point of beginning; thence N 00°04'17" W 64.70' along an East line of said property described in Volume 691 at Page 933 to a corner of said property; thence S 89°45'47" E 70.00' along a south line of said property described in said Volume 691 at Page 933 to a point, said point being the NW corner of that property described in Volume 538 at Page 82; thence S 00°04'17" W 64.70' along the West line of said property described in Volume 538 at Page 82 to the NE corner of that property described in Volume 580 at Page 198; thence N 89°45'47" W 70.00' along the North line of said property described in Volume 580 at Page 198 to the point of beginning.
