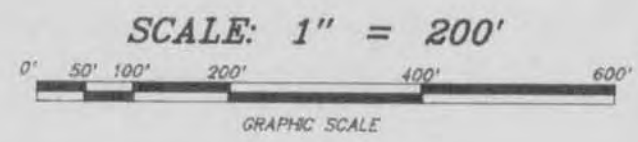


PLAT OF SURVEY

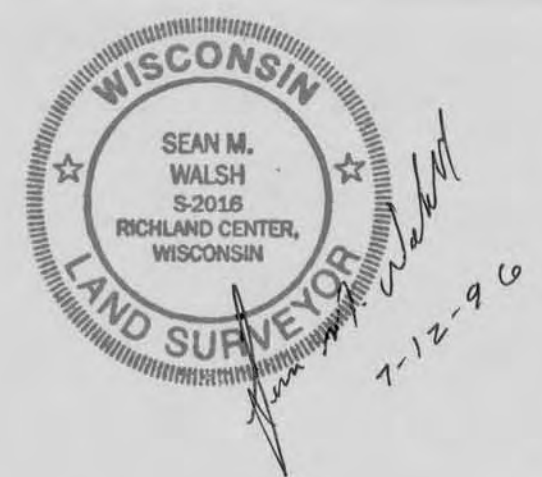

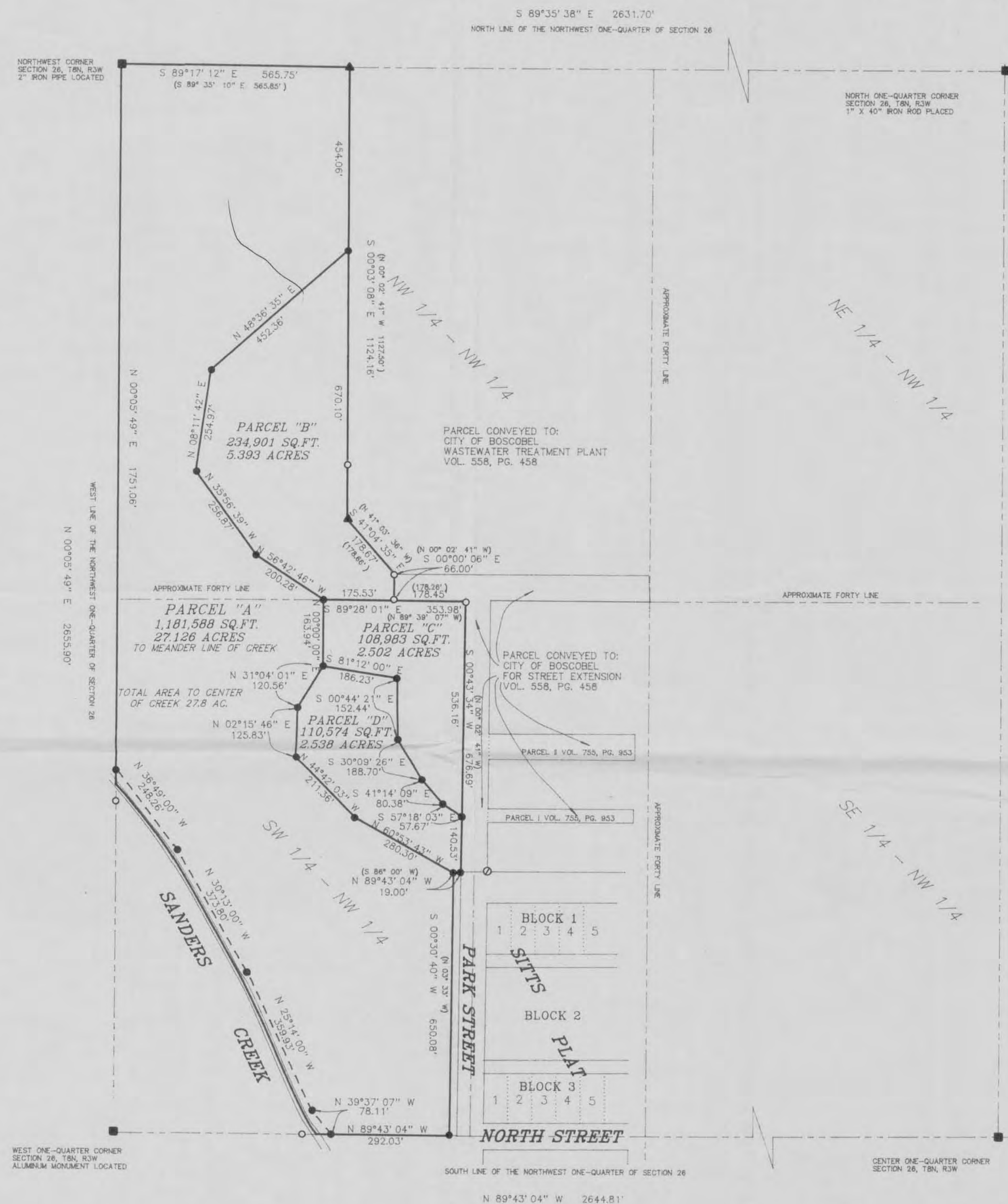

PARCEL "A"

All that part of the Northwest One-quarter of the Northwest One-quarter and part of the Southwest One-quarter of the Northwest One-quarter of Section 26, Township 8 North, Range 3 West, City of Boscobel, Grant County, Wisconsin, bounded and described as follows:

Commencing at the Northwest corner of Section 26, said point being the point of beginning of the parcel hereinafter described; thence South $89^{\circ} 17' 12''$ East, along the North line of the Northwest One-quarter, 565.75 feet (previously described as South $89^{\circ} 35' 10''$ East, 565.85 feet); thence South $00^{\circ} 03' 08''$ East, along the West line of a parcel described in Volume 558, page 458, 454.06 feet (previously described as bearing North $00^{\circ} 02' 41''$ West); thence South $48^{\circ} 36' 35''$ West, 452.36 feet; thence South $08^{\circ} 11' 42''$ West, 254.97 feet; thence South $35^{\circ} 56' 39''$ East, 256.87 feet; thence South $56^{\circ} 42' 46''$ East, 200.28 feet; thence South 163.94 feet; thence South $31^{\circ} 04' 01''$ West, 120.56 feet; thence South $02^{\circ} 15' 46''$ West, 125.83 feet; thence South $44^{\circ} 42' 03''$ East, 211.36 feet; thence South $60^{\circ} 53' 43''$ East, 280.30 feet; thence South $00^{\circ} 30' 40''$ West, 650.08 feet (previously described as bearing North $03^{\circ} 33' 33''$ West) to a point on the South line of the Northwest One-quarter of Section 26; thence North $89^{\circ} 43' 04''$ West, along said South line, 292.03 feet to a point on a line meandering the Northeasterly Shore of Sanders Creek; thence North $39^{\circ} 37' 07''$ West, along said meander line, 78.11 feet; thence North $25^{\circ} 14' 00''$ West, along said meander line, 359.93 feet; thence North $30^{\circ} 13' 00''$ West, along said meander line, 373.80 feet; thence North $36^{\circ} 49' 00''$ West, along said meander line, 248.26 feet to a point on the West line of the Northwest One-quarter of Section 26; thence North $00^{\circ} 05' 49''$ East, along said West line, 1751.06 feet to the point of beginning, containing 1,181,588 square feet or 27.126 acres of land.
