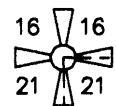

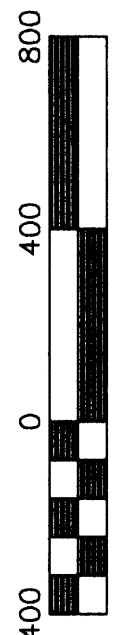


1" IRON BAR FOUND

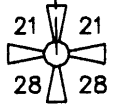

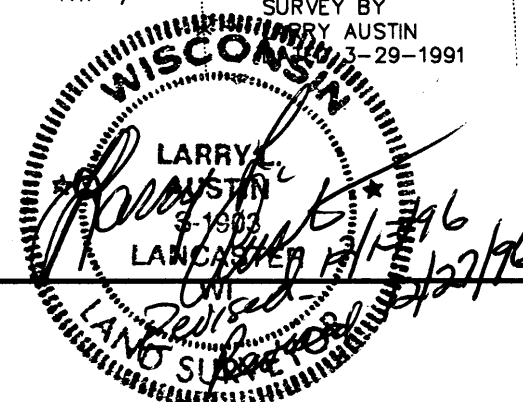
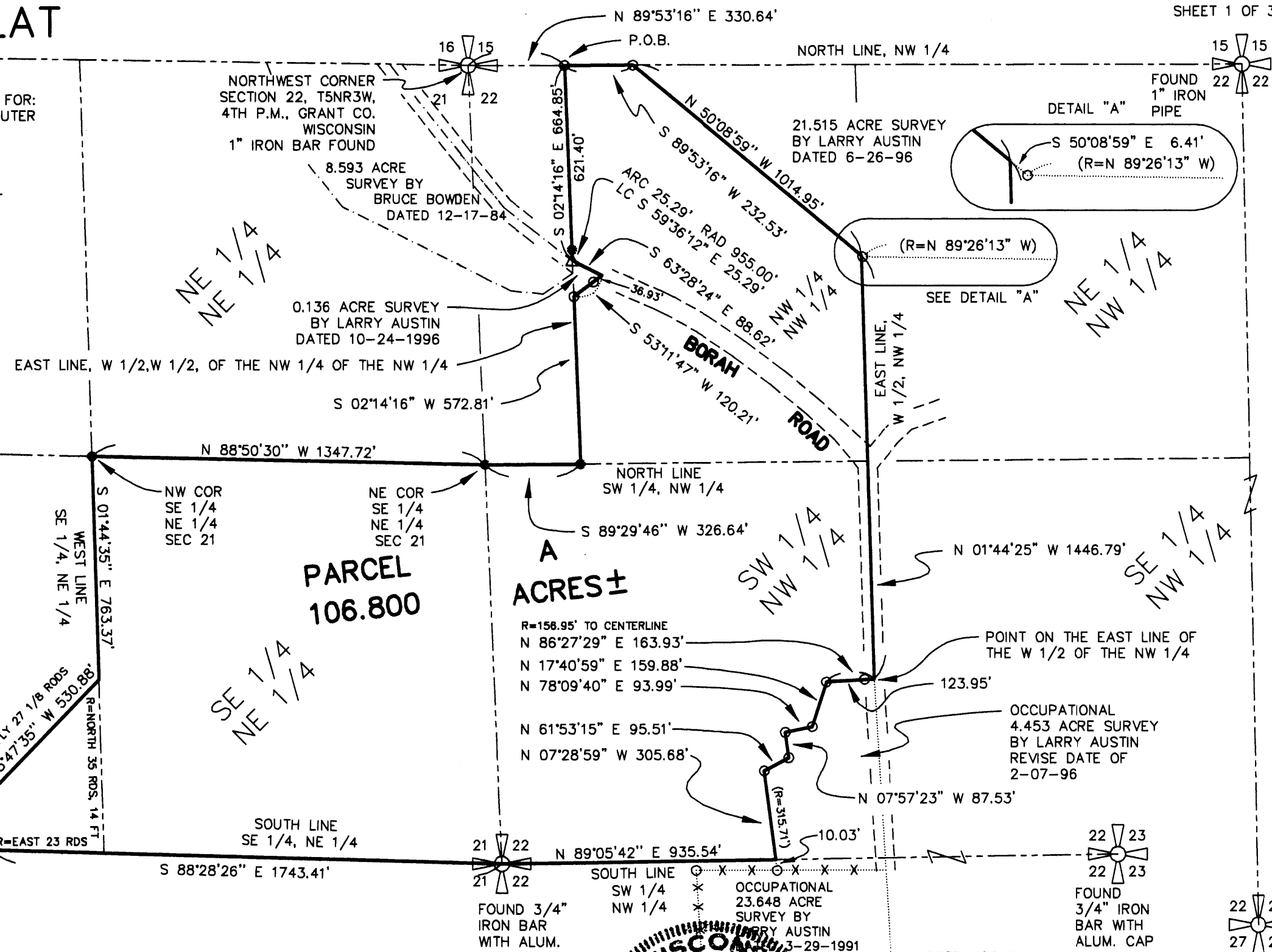

Of a parcel of land located in the Southwest 1/4 of the Northeast 1/4 and the Southeast 1/4 of the Northeast 1/4 of Section 21 and the Southwest 1/4 of the Northwest 1/4 and the Northwest 1/4 of the Northwest 1/4 of Section 22, all in T5N R3W of the 4th P.M., Grant County, Wisconsin, said parcel being more particularly described as follows:

Commencing at the Northwest corner of Section 22, T5N R3W of the 4th P.M., Grant County, Wisconsin, thence N 89deg 53min 16sec E 330.64 ft along the North line of the Northwest 1/4 of Section 22 to the point of beginning;  
THENCE S 02deg 14min 16sec E 664.85 ft along the East line of the West 1/2 of the West 1/2 of the Northwest 1/4 of the Northwest 1/4 of said Section 22 to a line of a 8.593 acre survey by Bruce Bowden dated 12-17-1984;  
THENCE Southeasterly 25.29 ft on the arc of a curve concave Northeasterly having a radius of 955.00 ft and a long chord which bears S 59deg 36min 12sec E 25.29 ft along said survey and along a 0.136 acre survey by Larry Austin dated 10-24-1996;


