All that part of the Northeast Quarter (NE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$), that part of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) and that part of the Southwest Quarter (SW $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section 22, Township 8 North, Range 1 West, Town of Muscoda, Grant County, Wisconsin bounded and described as follows:

Commencing at the Northwest Corner of said Section 22, a stone monument with a chiseled "X"; Thence East, 3332.22 feet; Thence South, 4237.46 feet to an iron pipe, the Point of Beginning;

Thence N 36°-56'-49" E, 126.23 feet to a reinforcing bar;

Thence S 44°-55'-10" E, 209.63 feet to a reinforcing bar;

Thence N 58°-10'-41" E, 819.48 feet to the centerline of Hickory Flat Road, said point being the P.C. of a curve to the right;

Thence 35.29 feet along the arc of said curve, radius of 4300.00 feet, the center of which lies to the Southwest, chord bearing S 11°-03'-26" E, 35.29 feet to the P.T. of said curve;

Thence leaving said centerline, S 58°-10'-41" W, 982.42 feet;

Thence N 37°-19'-04" W, 179.88 feet;

Thence N 36°-56'-49" E, 34.28 feet to the Point of Beginning;

Said parcel, inclusive of a portion of the Right-of-Way of Hickory Flat Road, contains 62,849.3 square feet or 1.442 acres of land, being subject to an Easement, sixty-six feet in width, described as follows:

Commencing at the Northwest Corner of Section 22, T. 8 N., R. 2 W., Town of Muscoda, Grant County, Wisconsin; Thence East, 3332.22 feet; Thence South, 4237.46 feet to an iron pipe, lying situated on the southeasterly line of an existing easement, the Point of Beginning;

Thence S 37°-19'-04" E, 159.20 feet;

Thence N 58°-10'-41" E, 70.48 feet;

Thence N 10°-06'-37" E, 44.36 feet;

Thence N 58°-10'-41" E, 881.79 feet to the centerline of Hickory Flat Road, said point being the P.C. of a curve to the right;

Thence 70.58 feet along the arc of said curve, radius of 4300.00 feet, the center of which lies to the southwest, chord bearing S 11°-03'-26" E, 70.58 feet to the P.T. of said curve;

Thence S 58°-10'-41" W, 827.34 feet;

Thence S 10°-06'-37" W, 44.36 feet;

Thence S 58°-10'-41" W, 159.86 feet;

Thence N 37°-19'-04" W, 200.56 feet to the southeasterly line of an existing easement;

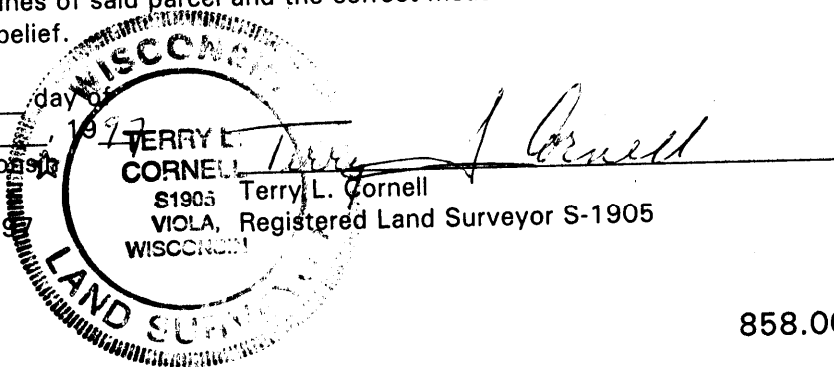
Thence N 36°-56'-49" E, 68.56 feet along said existing easement to the Point of Beginning.
