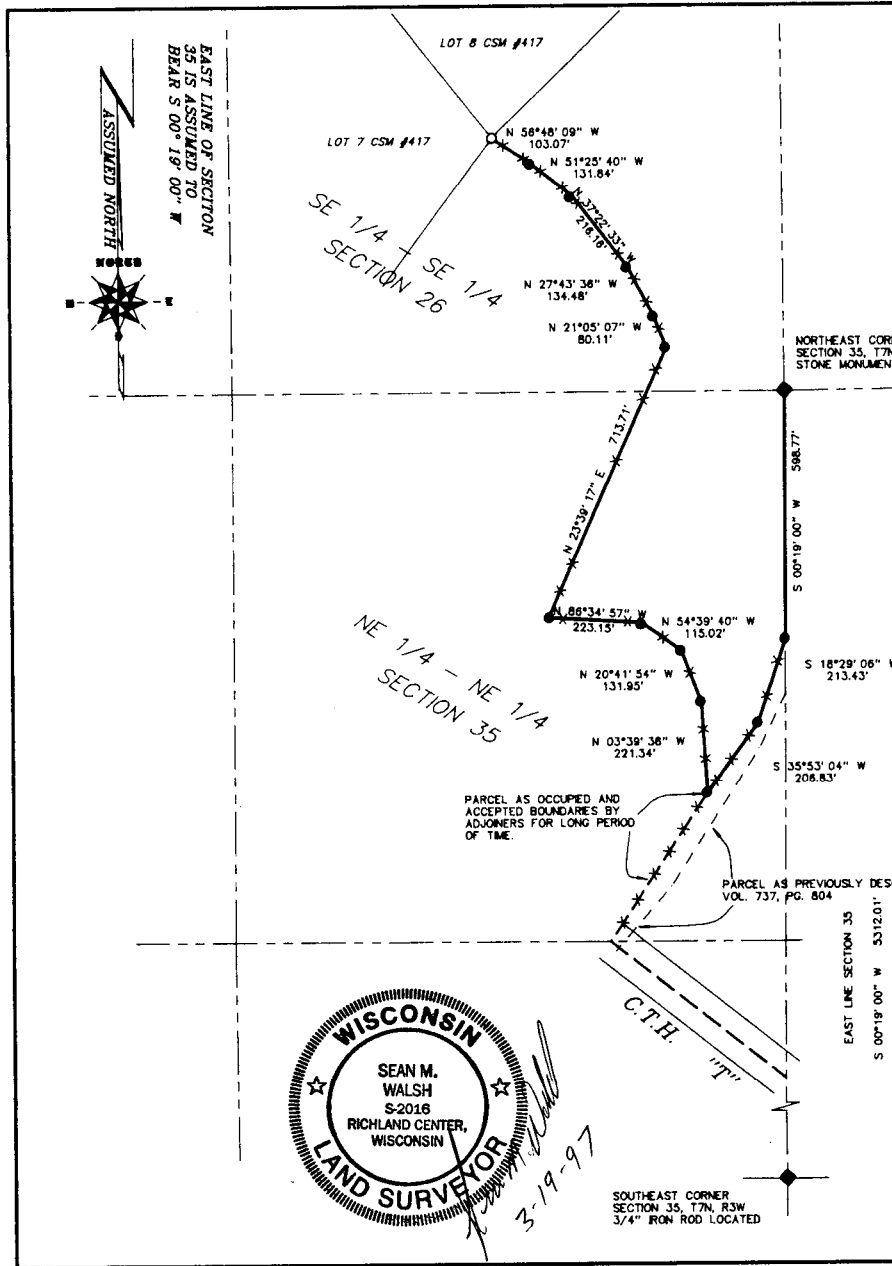

RAYNARD & MARCELLA STASKAL

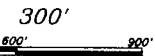
