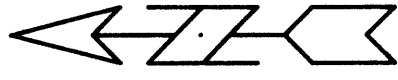
COMMENCING AT THE NORTH 1/4 CORNER OF SECTION 36, T4N R2W OF THE 4TH P.M., GRANT COUNTY WISCONSIN;  
THENCE S 00°03'58" E 2545.17' TO A 3/4" IRON BAR ON THE NORTH-SOUTH 1/4 LINE OF SAID SECTION 36, SAID BAR BEING THE POINT OF BEGINNING;  
THENCE S 00°03'58" E 387.97' TO A POINT IN THE CENTERLINE OF S.T.H. 81;  
THENCE N 68°51'36" W 220.31' TO A POINT IN THE CENTERLINE OF SAID S.T.H. 81;

THENCE NORTHWESTERLY 112.30' ON THE ARC OF A CURVE CONCAVE SOUTHWESTERLY, HAVING A RADIUS OF 2865.00' AND A LONG CHORD WHICH BEARS N 69°58'58" W 112.29' TO A POINT IN SAID CENTERLINE;  
THENCE N 45°22'36" W 167.99' TO A POINT IN THE CENTERLINE OF BAKER-JENTZ ROAD;  
THENCE N 12°34'40" E 137.11' TO A 3/4" IRON BAR;  
THENCE S 73°33'26" E 124.98' TO A 3/4" IRON BAR;  
THENCE N 06°43'36" E 81.96' TO A 3/4" IRON BAR;  
THENCE S 84°08'44" E 272.21' TO THE POINT OF BEGINNING, CONTAINING 2.846 ACRES, MORE OR LESS, AND BEING SUBJECT TO ANY AND ALL EASEMENTS OF RECORD, INCLUDING, BUT NOT LIMITED TO A R.O.W. FOR S.T.H. 81 AND BAKER-JENTZ ROAD.

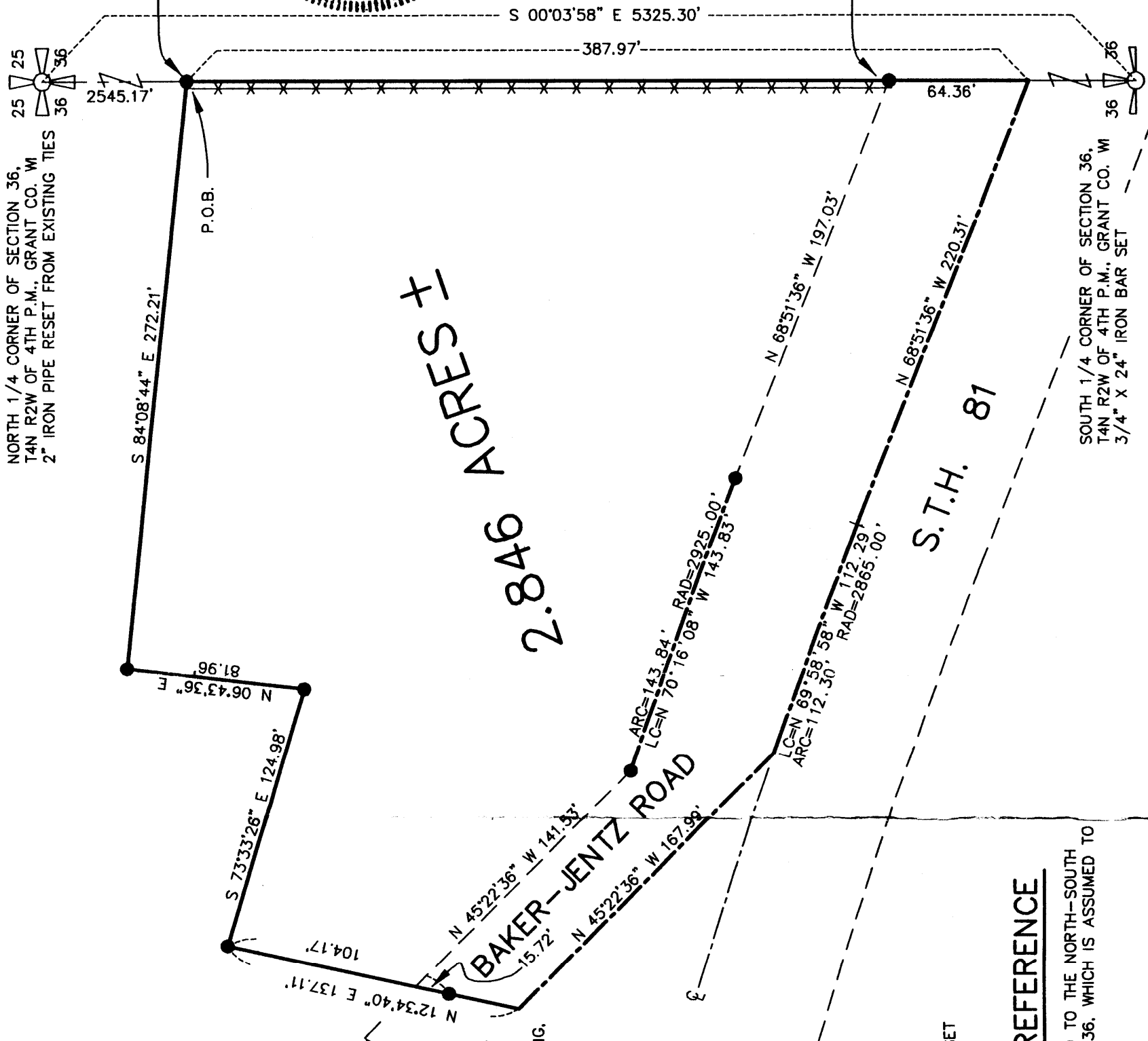
